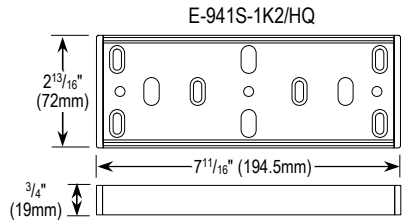
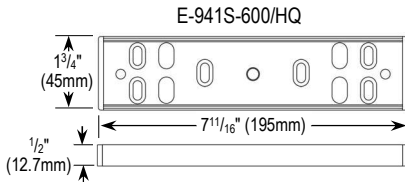

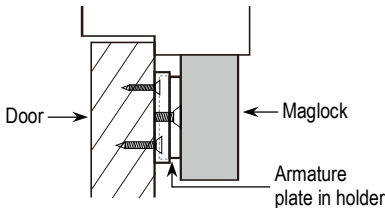


NOTE: The two models are not drawn to the same scale.

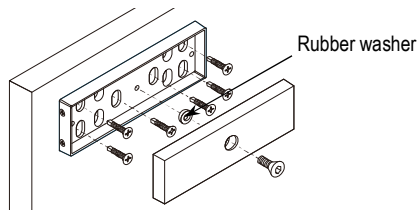
Installation

- The guide pins included with the maglock are not needed since the holder will keep the armature in place.
- For the same reason, only the rubber washer is necessary and requires using the shorter armature screw included with this product.
